Mealey (JFM) College Scholarship Fund Program is a scholarship program available to graduating high school seniors and undergraduate students who reside in CVHC housing communities (home or apartment) who are pursuing higher education. Scholarships ranging from \$250 to \$1,000 will be awarded to students who meet the eligibility criteria.
